Privacy and Anti-Spam in 2011

- Anti-Spam:
 - New Anti-spam law received royal assent in 2011 (but not in force until 2014)
- Privacy
 - PIPEDA in force since 2004
 - Videosurveillance
 - Privacy Risks of De-Identified and Aggregated Data
 - Targeted Online Advertising
 - Cross border data transfers
 - Facebook (file closed):

The changes Facebook has put in place in response to concerns we raised as part of our investigation last year are reasonable and meet the expectations set out under Canadian privacy law."

Google Buzz (service shut down following commissioner investigation and consumer backlash)

Antispam today

- CASL is arguably the world's most stringent anti-spam law
- Consent required prior to sending CEM (not an « optout » model like USA CAN-SPAM
- 5,000 complaints a week when CASL first took effect (hunders of thousands of complaints received)
- But ... is it working?
 - Confusing
 - Overly broad
 - Only 12 enforcement actions; no private right of action
 - Unconstitutional?

Loyalty Programs

- What is a loyalty program?
 - An agreement with customers to provide rewards in exchange for business
 - Consumer Protection Act (Ontario): "rewards points" are defined as points that are accumulated based on purchases, over time and that can be exchanged for goods or services at a later date

Points Expiry

- On January 1, 2018, new consumer protection regulations came into effect in Ontario that generally prohibit the expiry of rewards points due to the passage of time alone
- Several exemptions
- Similar regime in Quebec came into effect on August 1, 2019

Class Actions

- Air Miles
 - 5 year expiry rule was to go into effect on January 1, 2017
 - Class action continues despite Air Miles cancelling policy
- Aeroplan
 - Points cancelled if no account activity for 12 months or points not used with 7 years

- Continued monetization of data
- Increased personalization
- Digital first
- Geo-tracking, Bluetooth or other short range wireless protocols
- Consolidation and brand ecosystems

- Potential dilution of principles of foreseeability, remoteness & indeterminate liability
 - Ø Pioneer Corp. v. Godfrey
 - Ø Darmar Farms v. Syngenta

Trends in Product Liability & Regulation

- 2. Migration of class actions A.B.O.
 - Ø Ontario Bill 161
 - Carriage decided within 60 days
 - Ontario must be the preferable forum
 - Defence motions to narrow or dispose of the proceeding may be brought prior to certification
 - · Common questions must "predominate" over individual ones
 - Enhanced consideration of alternative procedures
 - The Class can only recover costs of notice of certification if the claims succeed
 - Direct right of costs recovery against third party funders
 - · Defendants have direct right of appeal to CA

What is supply chain management / risk?

- 85% of global supply chains have experienced at least one disruption in the past 12 months
- Canadian firms are actively dealing with two disruptions: coronavirus and blockades
- Risks are on the rise
 - Protectionist policies
 - Environmental

Commercial benefits to supply chain review

- Companies who perform regular supply chain risk management reviews spend 50% less time dealing with disruptions when they occur
- Opportunities to find efficiencies in supply chain and inventory management
- "Bottom line" impact (decrease in purchasing and production costs, increase cash flow, increase in profit leverage)
- "Brand" impact (i.e.: greening the supply chain)

A Best-Friends Trade War

- March 1, 2018: US imposes 25% tariff on steel imports and 10% tariff on aluminum imports based on threat to "national security" (section 232)
- June 1, 2018: Canada initiates challenge of US section
 232 tariffs at World Trade Organization
- July 1, 2018: Canada imposes 25% and 10% retaliatory surtaxes on steel and aluminum products, food, beverages, furnishings, and other consumer and retail products and accessories from the United States

A Best-Friends Trade War (cont'd)

- May 17, 2019: Canada and US agree to "ceasefire"
 - tariffs and surtaxes removed
 - no quotas, but snapback available
 - restrictions on retaliation
 - withdraw WTO litigation

Lessons for Defending Your Supply Chain

- consultations pre-implementation to seek exclusion of your imports
- consultations and remissions during and after implementation
- assessing drivers of retaliatory tariff liability on import classification, valuation, origin
- sourcing alternatives
- communications with suppliers and customers
- allocation of risk in contracts

Beyond Tariffs: Shocks to the Supply Chain

- trade remedies vs consumer products anti-dumping, countervail, safeguard
- export and technology transfer controls (and entity list designations)
- economic sanctions
- anti-bribery laws
- human rights measures such as modern slavery laws

Preparing for COVID-19

- Appoint individual(s) responsible for developing an overall communications and contingency plan, to act as liaison with employees, affiliated companies, suppliers, contractors, customers, local government and health agencies, review contracts, etc.
- Prepare contact list of essential employees, contractors, vendors, suppliers, etc.
- Consider the need to prepare for cross-training of staff
- Determine whether employees can work remotely
- Ensure that computer network can support remote access by employees

Preparing for COVID-19

- Establish a telephone "hotline" and/or web portal for employees to facilitate communication if employees cannot attend at the workplace
- Provide employees with up to date and accurate information regarding COVID-19, measures to prevent spread, comply with Ministry of Health directives
- Review leave of absence/vacation policies
- Caution employees against non-essential personal travel to high-risk areas and prohibit all non-essential business travel to high-risk areas

Preparing for COVID-19

- Address how to deal with quarantined employees
- Direct employees who believe that they may have been exposed to COVID-19, or are exhibiting symptoms of COVID-19 that they must immediately report to Human Resources, and will not be permitted to report to work until they are cleared by a medical professional
- Consider on-site or external health-screening clinics or medical support services
- Regularly review and update Plan as COVID-19 continues to evolve, and co-ordinate with global corporate plan, if applicable.

Work Refusals

- Employees have the right to refuse to work or to perform a task where it is likely to endanger their health or put them at risk.
- Employers who receive a COVID-19 related refusal to work must comply with obligations under applicable occupational health and safety legislation.
- Employers are required to investigate a safety-related work refusal.
- Employees who exercise a legitimate health and safety work refusal cannot be disciplined, threatened or dismissed.

Discrimination and Harassment

- Employers must not make assumptions based on stereotypes and must ensure that their employees do not do so
- Barring someone from a place of employment because of race, ethnicity, or place of origin (perceived or otherwise) is contrary to human rights legislation
- Duty to accommodate may also arise
